Updated Cleaning Standards

We will incorporate CDC and EPA approved cleaning solutions to our established regiment to clean and disinfect our entire facility. Sanitation protocols will vary according to type of item and surface type. In addition to remixed products from Melaleuca & Zogics, we will use a mixture of 70% isopropyl solution & hydrogen peroxide for decontamination of high touch surfaces



Cleaning Schedule

- Exhibits: Before, during and in between sessions and will be thoroughly cleaned at the end of each day.
- Bathrooms: Thoroughly cleaned and disinfected at the end of each day; all doors, handles for faucets and toilets, countertops and diaper changing stations will be wiped down with disinfectant between sessions. and will be .
- The lobby area and gift shop will be wiped down/ sprayed with disinfectant between sessions.

Handwashing Request and Rewards



Upon entering the Museum we are asking all guests to wash their hands or to use hand sanitizer before exploring. To encourage frequent hand washing,/sanitizing, staff will be patrolling with reward stickers. Staff will be required to follow a schedule for hand washing.

Mask Policy

CMA Staff are required to wear masks while assisting guests. While the CMA is not requiring its guests to wear masks, the CDC recommends that persons 12 years and older wear cloth face coverings in public settings. Cloth face coverings provide an extra layer to help prevent the respiratory droplets from traveling in the air and onto other people.



Distancing



For the health and well being of others, please try to maintain a distance of 6ft between your family and others while exploring. We also ask that you do not enter the Museum more than five (5) minutes before your session begins and to depart promptly at the end of your session. Your cooperation is appreciated and will ensure that our staff can properly clean and disinfect our facility before the next session begins.

Learning Manipulatives

Each exhibit has a reduced number of learning manipulatives for our initial phase of opening. When applicable, we ask for your help in placing high touch item in the “used” bins in exhibits. Staff will be rotating components on a frequent schedule and will wipe down surfaces as much as possible during a session. Hand sanitizers are located throughout the Museum and guests are welcome to bring their own disinfecting wipes to use at will.



Health Policy



CMA Staff is following “STAY HOME STAY HEALTHY” order. Employees know to stay home if not feeling well. Employees will be screened for symptoms before entering the building and will not be permitted to work if they are experiencing any flu-like symptoms or symptoms related to Covid-19.

CMA guests are asked to reschedule their visit if anyone in their party is not feeling well or has any of the following symptoms: cough, fever, sore throat, muscle aches, shortness of breath.

Timed Admission

Timed entry tickets are required for members and general admission guests to allow for limited capacity. Admission is \$7 per person and everyone over one year old must purchase admission. All ticket sales are final and cannot be transferred to a different session. This is due to the current health climate and the requirement to manage our capacity. Purchase online at cmalaf.org.
